
Student	Katie reported there was a good response to the student session for the

Access to menstrual products in MN schools is a need that can be met by mandating schools to have supplies available. Other states and organizations are looking at this from several angles such as addressing socio-economic issues, mental health, hygiene and equity. The efforts during the 2022 MN legislative session failed in the house and the senate. The bills will be brought forward again
